

SMIRNOFF ICE SMASH SWEEPS

1. This sweepstakes begins at or after 12:01 a.m. Eastern Time (ET) on October 1, 2019 and ends at 11:59:59 p.m. (ET) on December 31, 2019. To enter, follow these two (2) steps:

 - b. Provide your name, date of birth, state, zip code**, telephone number and e-mail address and follow the on-screen instructions.

**The provided state/zip code will be used to determine if an entrant is eligible for entry in a State random drawing, in addition to the National random drawing (as discussed below).
